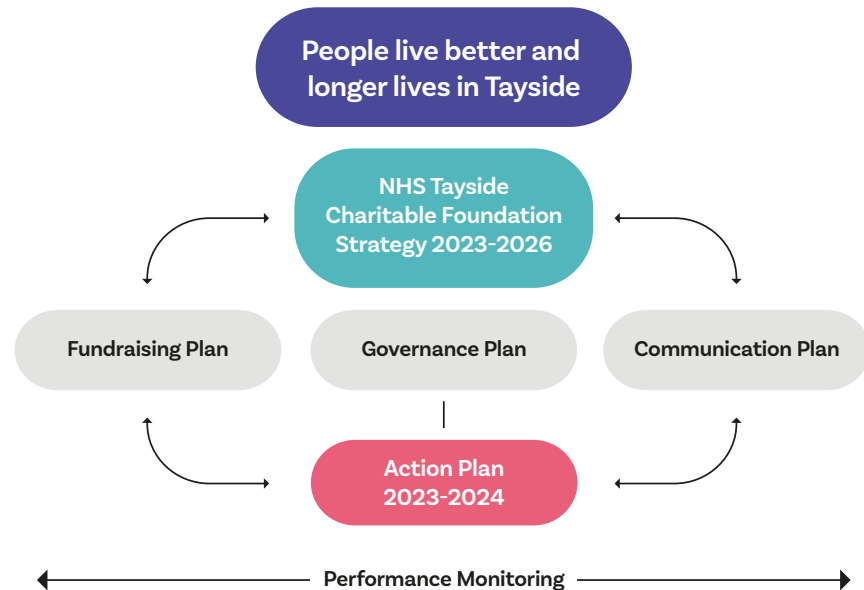
About Us:

NHS Tayside Charitable Foundation is a Registered Scottish Charity (SCO11042) which supports NHS Tayside hospitals and services.

It is supported by donations and legacies from patients, their relatives, the general public and other organisations. The fund makes a big difference to patients and their families across Tayside and this new strategy will increase awareness and improve communication of the funding on offer and opportunities for fundraising activity.

This Strategy provides the context, governance and strategic direction of how the charity will deliver the vision and support the priorities co-produced with the people we support. The Strategy is the overarching document complimented by a Fundraising Plan, Governance Plan and Communication Plan which are all monitored through the Action Plan.

Throughout the Strategy are key structures and components which will ensure growth and sustainability – now and for the coming years.

Based on local data and evidence from services it is a vision that links through to our mission and priorities.

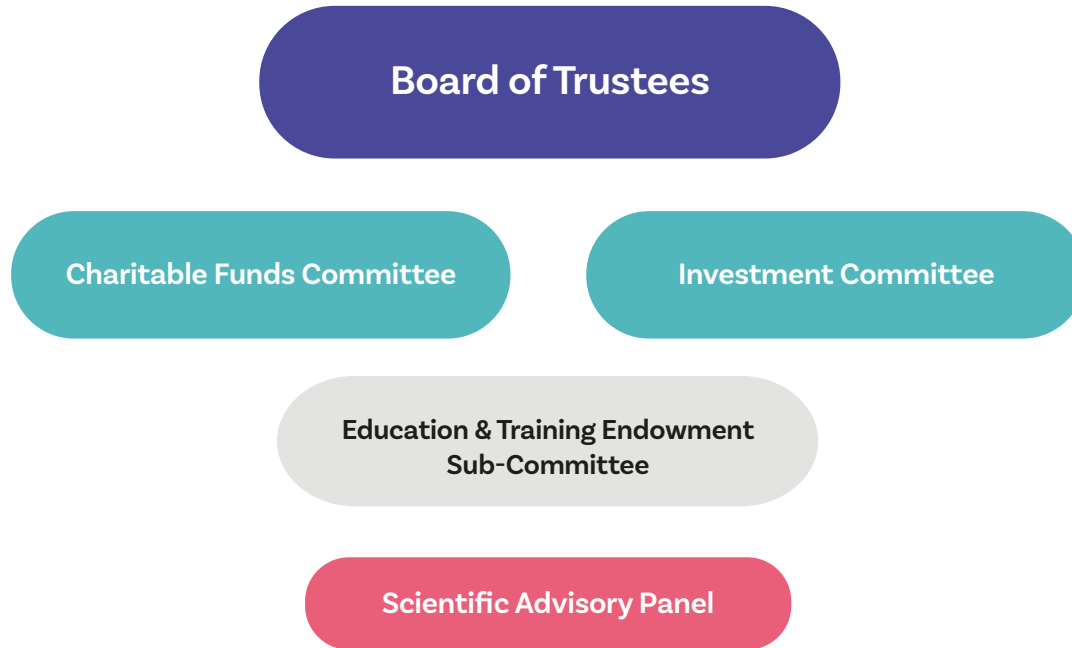
Our mission will set the direction of travel in delivering the vision and is:

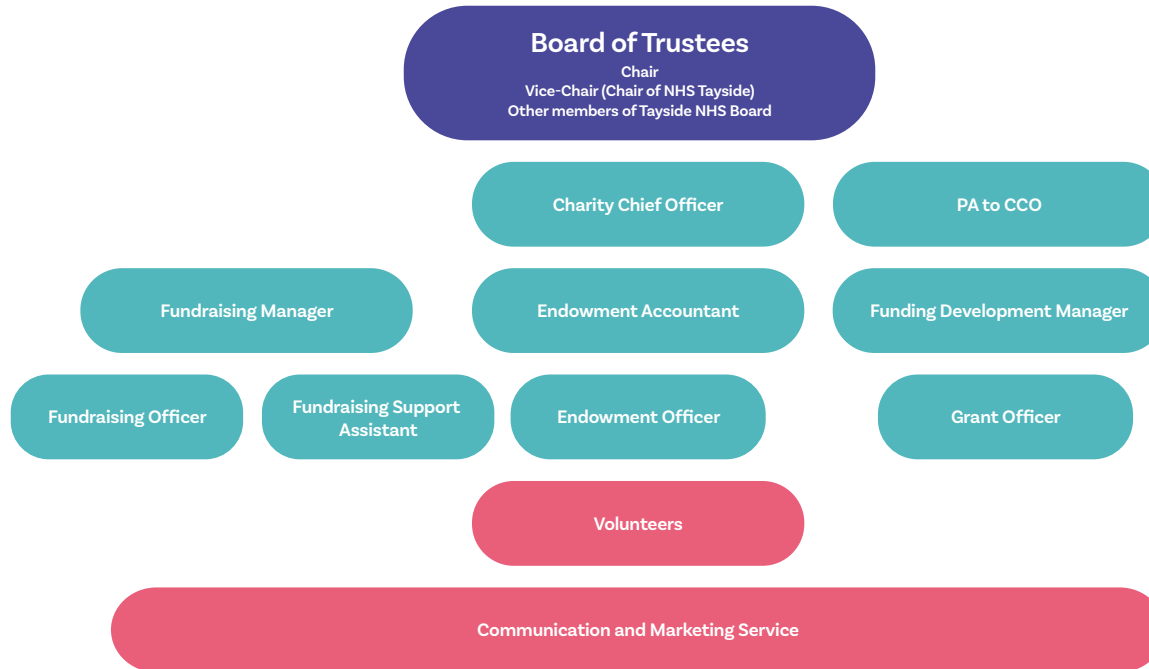
Governance Structure:

To deliver on the vision, values and mission the governance structure in place provides clear assurance of transparent decision making and that our funding and investments are socially and environmentally responsible. All of the committees meet quarterly with updates throughout the year.



Staff Team:

The core staff team in blue deliver, develop and manage all activity within the charity's charter. The support in pink provides a link to NHS Tayside and to our communities.



Priorities:

In order to set the priorities, we explored the local data and evidence on what was making a big impact on people's lives. This clear set of priorities will help shape our funding and support offer:

✓ **Improving** and Supporting Physical and Mental Health

✓ **Unlocking** Health Innovation

✓ **Reducing** Substance Use

✓ **Tackling** Obesity

✓ **Promoting** Child Health

✓ **Contributing** to Environmental Sustainability

The cross-cutting theme that is at the core of everything we do is prevention, to support NHS Tayside and the community we will encourage a shift to preventative services, projects and activity.

Our Purpose:

As part of the charter governing the charity our core purpose is the advancement of health, through:



1.

Improvement in the physical and mental health of the people of Scotland.

2.

The prevention, diagnosis and treatment of illness.

3.

The provision of services and facilities in connection to the above; and

4.

The research into any matters relating to the causes, prevention, diagnosis or

5.

Treatment of illness, or into such other matters relating to the health service as the Trustees see fit

6.

To observe any conditions attached to a donation or legacy prescribed by a donor to the charity, so far as is reasonably practicable, and consistent with the above purpose and the law.

Delivery:

To deliver on the vision, purpose and priorities there will be 4 key areas of delivery –our Fundraising Plan, an Improved presence through our Communication Plan, increased collaboration across Tayside and how we distribute funding through a new package of support.

1

Fundraising

The plan contains details of the new hub, Volunteering, Partnership opportunities, our fundraising offer and actions to further develop the Gift Shop in Ninewells.

2

Collaboration & Partnerships

Working with partners, services and local organisations will help to increase the impact of funding and services through reduced duplication and efficient pathways to funding, support and advice.

3

Presence

A key development will be improving the communication and marketing of the charity, work underway and opportunities to get involved. The plan details key activity to improve the reporting, awareness and application process.

4

Funding Programme

A key part of the NHS Tayside Charitable Foundation is the distribution of funds to where they are needed most. The new funding areas are based on local data and need explored through local consultation. NHS Tayside Charitable Foundation also provides funding and support to NHS Tayside services which is part of the internal funding package.

Funding Programme:



Innovate

Groups can apply for funding between £500 and £25,000 (maximum of £20,000 for two years and a maximum of £25,000 over three years) to establish innovative projects to tackle issues affecting our community.



Prevent

Groups can apply for funding between £50,000-£100,000 over 3 years (max £250,000) to help support the priorities focused on prevention.



Invest

NHS Tayside colleagues can claim up to £500 for fundraising activities generating over £1,000 to help deliver the charitable priorities.



Support

The Foundation support programme includes providing signposting to other funders, partnership opportunities and links to key organisations across Tayside and beyond.

Stakeholder Engagement:

In preparing this strategy there was engagement across Tayside with our key stakeholders, donors, partners and the people of Tayside.

Ongoing communication and engagement are essential elements in our action plan and will ensure we continue to provide the support people need to deliver the vision.

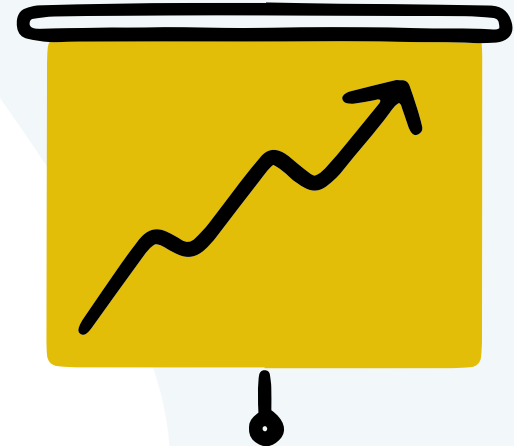


Performance Framework:

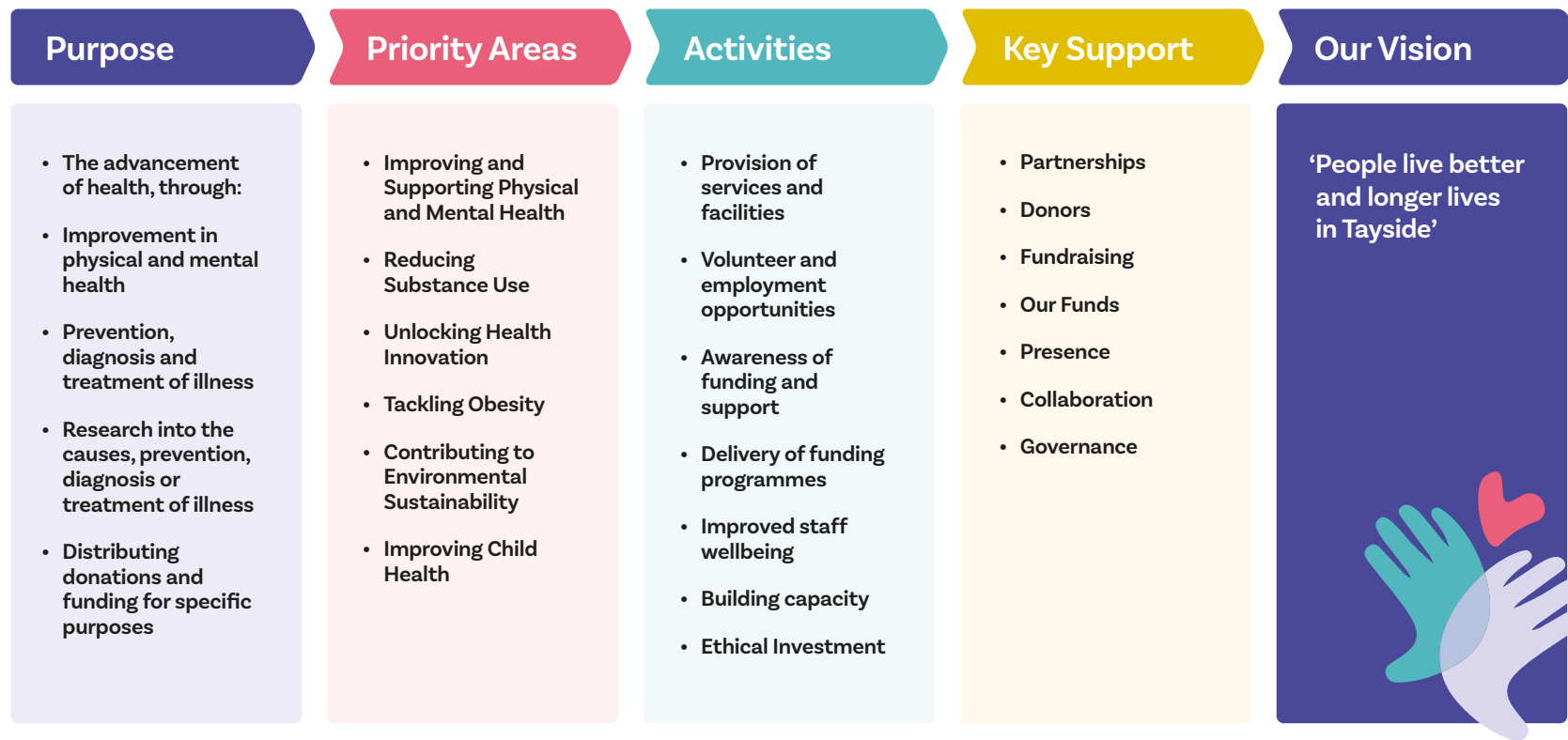
Specific, Measurable, Attainable, Relevant, Timely
